

## Terms and Conditions for Discover Dairy Healthy Bones Action Week 2018 Competition.

1. Instructions on how to enter the Discover Dairy Healthy Bones Action Week 2018 Competition form part of these Terms and Conditions of entry.
2. The Competition is an initiative of Dairy Australia Limited (ACN 105 227 987), an Australian public company limited by guarantee with its registered office at Level 3, HWT Tower, 40 City Road, Southbank, Victoria, 3006 ("Dairy Australia").
3. The total prize pool for this Competition comprises one (1) \$300 Rebel Sports Voucher.
4. By submitting an entry for the Competition entrants (hereafter, "You") are deemed to have accepted and agreed these Terms and Conditions ("Ts&Cs"). Applicants who do not comply with these Ts&Cs, or who do not otherwise satisfy the entry criteria outlined herein shall be ineligible to enter the Competition or collect a prize.
5. The Competition is open to all Australian primary school teachers currently employed at a primary school. Entry is free. Employees of Dairy Australia and their immediate families and agencies associated with the Competition are ineligible to enter.
6. This is a competition of skill. Chance plays no part in determining the winner. Entries will be judged on their creative merit and demonstration of bone education to students.
7. Entrants can enter as many times as they wish.
8. To select a winner, a panel of two (2) Dairy Australia judges will judge all entries and select a winner based on its creative merit and demonstration of bone education to students
9. You may submit your entry at any time between 11:00am AEST Thursday, 9<sup>th</sup> August 2018 and 11:59pm 26<sup>th</sup> August 2018 ("the Competition Period"). The successful entry will be notified by Dairy Australia via return email and be asked to provide their address details for prize delivery. If the prize winner does not respond with their address details within 48 hours of being notified, the prize will be awarded to someone else.
10. No responsibility is accepted by Dairy Australia for late, lost, incomplete or misdirected entries.
11. The judges' decision shall be final and no correspondence shall be entered into.
12. Prizes are not transferable or exchangeable and cannot be redeemed as a cash equivalent.
